The two smelled smoke while on their route in Ormond Beach, Florida. A neighbor told Thomas a nearby home was on fire and someone was inside, so he rushed into the burning home to help.

He could not find anyone, so he came back outside to see if the resident escaped. When the neighbor told him no one had come out, he braved the flames and thick smoke once again. This time, he found a woman unconscious and brought her to the front door, where Gardiner helped pull them both out.

Thomas does not consider himself a hero; he insists he is a regular person who did what anyone would do.

Thomas has been with Waste Pro since it began service in Ormond Beach in 2014 and received a \$10,000 Safety Award from the company in 2017, which he received for his flawless performance over the last three years. Gardiner has been with the company since 2016.

Waste Pro is proud to announce one of its employees is part of an organization receiving national recognition for its environmental efforts.

Tracy Meehan, Municipal Marketing Manager of Waste Pro's Southwest Florida Region, currently serves as Board President of Keep Pinellas Beautiful (KPB), the local affiliate of Keep America Beautiful.

In April, KPB received the Keep America Beautiful Affiliate Award of Excellence for its initiatives, programs, and projects aimed at protecting the environment.

In 2016, Waste Pro was recognized as the 2015 KPB Recycling Partner for their help in KPB's mission, including donating containers to local events. That same year, Meehan was also named one of Waste 360's 40 Under 40.



Waste Pro Taking Action to Address Nationwide Driver Shortage

This year, Waste Pro created the Co-Heart Program, which provides current employees inhouse training and state certification to obtain their CDL. Since its creation in 2015, the program has successfully helped more than 100 employees obtain their CDL.

Waste Pro expects to have two Driver Training Centers (DTC) up and running this year that will help more drivers to receive their CDL.

Right now, there is a CDL driver shortage across the industry. The new DTCs will allow newly-hired drivers and current employees who are newly certified to attend training classes that cover topics including customer service, safety, vehicle specifics, and more. The centers will be located in Sanford, Florida and Atlanta, Georgia.



Waste Pro Teams with FDC to Give Offenders a Fresh Job-Start

Thanks to a program launched earlier this year, Waste Pro and the Florida Department of Corrections (FDC) are now working together to offer parolees and other offenders a fresh job-

The FDC reviews qualified candidates through an application process, then makes recommendations to Waste Pro, who will then carefully select candidates for further consideration. The jobs they can fill include drivers, mechanics,

Anyone convicted of violent crimes or sex offenses will not be considered. The FDC says employment is essential to reducing the likelihood of offenders committing another crime.

"This partnership with the Florida Department of Corrections is a unique opportunity to provide employment opportunities, easing the transition following their release and aiding in their continued growth," said John Jennings, President & CEO of Waste Pro. "We are excited about the program and look forward to a long relationship."
